

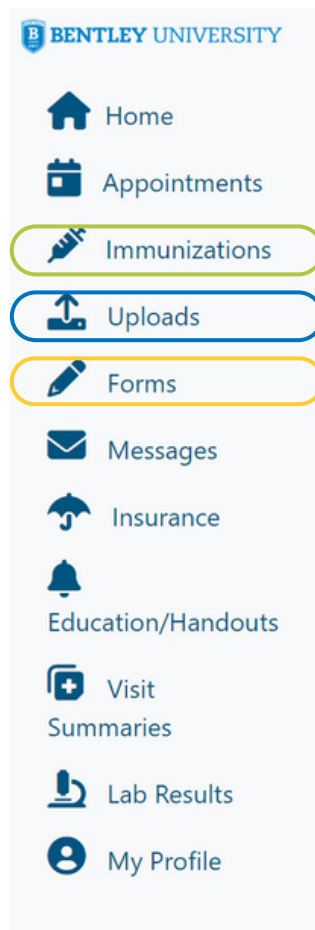
Health & Immunization Requirements

Welcome, New Falcons! As part of your enrollment, the Massachusetts Department of Public Health requires all full-time university students (Undergraduate \geq 12 credits; Graduate \geq 9 credits) to submit health information through our secure Student Health Portal (bentley.medicatconnect.com).

Requirements are due June 15 for Fall enrollment or December 6 for Spring enrollment.

Your move-in day may be impacted if you are not compliant with these requirements prior to your arrival on campus. You may also be charged a \$50 nonrefundable fee for non-compliance and a HOLD will be placed on your account preventing you from registering for next semester's classes.

All health information submitted through the portal is confidential. We are unable to accept emailed, faxed, or mailed documents. Use the navigation menu tabs on the lefthand side of the portal to complete the steps below.



STEP 1: FORMS

- Health History Form
- New Student Tuberculosis (TB) Risk Assessment
 - Based on your answers, the form will indicate to you whether TB testing is also required. Tests should be dated no earlier than 12 months prior to semester start.
- Consent to Treat Under 18 (*to be filled out by parent/guardian only if you are under 18 years old*)

STEP 2: IMMUNIZATIONS

- Enter the dates you received each vaccine, in Month/Day/Year format.
 - The dropdown menu also has options for lab titer results or evidence of having had the illness, if applicable.

STEP 3: UPLOADS

- Upload an immunization record. This can be the [Bentley Immunization Record form](#) **OR** a similar document that contains your name, date of birth, vaccine dates, and healthcare provider signature (stamp or letterhead also accepted).
- Upload other documents if applicable, such as TB test results, antibody titer results, or waiver forms.

VERIFICATION PROCESS

Please allow up to 7 business days for our verification partner, Mediat Compliance Services (MCS) to review your record. We will reach out if any requirements are incomplete. Check your Bentley email regularly for messages from complianceservices@medicat.com or GA_HealthCenter@bentley.edu.

Required Immunizations & TB Screening Information

VACCINE	REQUIREMENTS
Hepatitis B	Three doses of Engerix-B or Recombivax-HB; OR two doses of Heplisav-B; OR documentation of a positive Hepatitis B surface antibody titer (anti-HBs)
Measles, Mumps, Rubella (MMR)	Two doses of the combined vaccine, given at least one month apart; the first dose must be on or after your first birthday. A blood test (titer) to determine immunity is acceptable. If not immune to all three parts of the vaccine, you will need to complete the combined vaccination series. History of measles, mumps and/or rubella is not acceptable.
Meningococcal ACWY	Applies to students 21 years of age and under: One dose of MenACWY vaccine received on or after your 16th birthday. Alternatively, we can accept a signed meningococcal vaccine waiver (<i>available on the Uploads tab</i>).
Tetanus-Diphtheria-Pertussis (Tdap)	Tdap at or after age 7, but ideally age 11 and older. If Tdap was more than 10 years ago, a Td (tetanus) booster or repeat Tdap is also required.
Varicella (Chicken Pox)	Two doses given at least one month apart; the first dose must be on or after your first birthday. A blood test (titer) to determine immunity is acceptable OR documentation of a reliable history of varicella disease verified by a healthcare provider.
Tuberculosis (TB) Screening	Complete the New Student Tuberculosis (TB) Risk Assessment on the Forms tab. If you answer “Yes” to any question, a tuberculosis test is also required. An IGRA (blood) test is preferred over a TST (skin) test. Tests should ideally be performed within 6 months prior to semester start, but 1 year prior is also acceptable. Upload official lab results or ask your provider to complete the TB Medical Provider Form .

In addition to those listed above, we also recommend (but do not require) the following vaccines: COVID-19, Seasonal Influenza, HPV, Meningococcal B, and Hepatitis A.

Immunization requirements are subject to change based on MA Department of Public Health guidance.
